ELIGIBILITY:

DURATION: Fiction and nonfiction films below 40 mins.

1. Films that are not online on any streaming platform or YouTube.

2. Web series, music videos, commercials, corporate films, and VR are not accepted.

FORMAT: Documentary or Short Film could be shot on any camera, but English subtitles are

compulsory for languages other than English.

SUBMISSION: Films to be submitted online only, no physical submission to be accepted.

SELECTION PROCESS: Submission to the festival doesn't guarantee the screening. All the Documentaries or Short Films submitted to SPIFF will be confidentially screened by a programming team appointed by Arogya Sena. Films to be screened in the final selection of the film festival will be exclusively judged on the artistic merit of the film without regard to the cost of production or the subject. As SPIFF receives submissions from across the globe, the final selection is becoming incredibly competitive. The programming team reserves the right to reject any film that doesn't fit the artistic excellence that SPIFF seeks. There wouldn't be any refund if the film is rejected. We can't provide any feedback.

Only a RIGHT HOLDER of the film is allowed to submit the film.

FINAL SCREENING: Only films shortlisted by the programming team will be eligible for final screenings and awards.
